#### **JCAR Postpones April Meeting**

Last week, we asked PCA contractors to contact the Illinois elected officials who serve on JCAR (Joint Committee on Administrative Rules) to oppose the emergency rules published this month by the Illinois Workers Compensation Commission. These rules, in essence, allow any employee of an "essential business" as defined in Governor J.B. Pritzker's Executive Order (which includes construction) to likely be able to get workers' compensation benefits if they are diagnosed with the COVID-19 virus. While the members of JCAR have the ability to vote to object or suspend this emergency rule, they, unfortunately, postponed their April meeting late last Friday evening. The PCA, therefore, has joined our legislative partners at IMSCA in financial support of the Illinois Manufacturers Association and the Illinois Retail Merchants Association lawsuit to block the Workers Compensation emergency rule. We will keep everyone apprised of the lawsuit as it unfolds and we thank everyone who took the time to participate in this legislative action.

On January 15, 2019, Governor Pritzker signed Public Act 100-1177 which amended the Illinois' Prevailing Wage Act (the "Act") in many ways. One noteworthy amendment to the Act is the requirement that the Illinois Department of Labor develop an online database for contractors to use to submit certified payrolls. 
## **Construction Education Institute** Classes Now Online
