## MAY MEMBERSHIP MEETING

### **Mental Health Awareness and Succession Planning**

The well-attended and information-packed PCA meeting at Maggiano's in Oak Brook on May 10, 2023 in a two-part format focused first on mental health and suicide awareness facts and advice during a one-hour seminar led by Screen Safe and ERS co-founder Bill Heffernan. The PCA has elected to address the serious issue of alarmingly higher rates of death by suicide in the skilled trades and construction industry. Rounding out Heffernan's insightful presentation was an explanation by ERS Account Manager Kathleen Horton on the variety of practical resources available for life balance and overall mental health on the ERS website (<a href="www.ers-eap.org">www.ers-eap.org</a>). Following the dinner, the 90-minute program with panelists Paul Lally and Dave Friedman (WIPFLI) and Jason Loebach (Chitkowski Law Office) thoroughly explored the key topic of "succession planning" specifically and appropriately as it relates to the signatory construction and service contracting industry.

The panelists offered practical guidance from professional accounting, business, legal and financial standpoints while fielding questions and comments from audience members throughout the session. Adding credible and useful perspectives to the discussion were representatives from Federated Insurance (Kenny Keil and Brandon Olson), and the program was further accented by actual but unnamed member experiences from numerous Association members delivered by moderator S.J. Peters (PCA's Executive Director), and real-life examples of triumphs, failures and mediocre results in company or organization succession planning scenarios. The panelists encouraged attendees to contact them for additional information and for consulting in the future, while unanimously emphasizing the fact that the earlier they start taking action toward succession planning, the greater the return and less expensive the (necessary) process will be.

## PRESIDENT'S MESSAGE



The PCA: Always At Work for Our Members By Brian Kennedy, President – PCA of Greater Chicago

An early memory I have of my introduction to the *PCA* of Greater Chicago is a meeting that explained our Drug Free Alliance. The overview of the drug program – along with questions and comments – gave a thorough understanding of what those of us gathered in that room needed to know based on our mutual experience. It was a unified audience. The topic was (and is) important, and yet that shared "common ground" with my peers applies to a wide range of topics unique to being a signatory PCA plumbing contractor in Chicagoland. We speak in one voice in CBA negotiations, rely equally on our appointed management trustees to the Benefit Funds, and elect our own Association leadership board. As PCA employers we operate under the same union

agreements with Local 130, draw a vast majority of our skilled workforce from the union hall and the JAC, attend Association meetings to network and gain information to improve our businesses, attend seminars and CE classes geared to our needs and interests, and much more.

A look back at the past several membership events demonstrates how and why the PCA both innovates and keeps pace with our contractor constituents. Our May 10, 2023 meeting covered the crucial and concerning phenomenon of suicide in the construction industry and offered practical and insightful advice to aid in preventing more tragedies. Too many of us regrettably know of someone we lost this way, and I assure you we won't stop addressing this crisis. We also took a deep look into succession planning as our main program and hopefully demystified and provided helpful and useful strategies for contractors in various stages of their companies' "lifespans" and future.

Our prior March 2023 meeting delved into the new 401k option for Local 130 members and furnished a clear explanation while answering all questions before the ratification vote. In November of 2022, we welcomed as our keynote speaker UA General President Mark McManus (and included Local 130 officials) to affirm the PCA's strong connection with our labor counterparts. Last October, legislative initiatives (including the IMSCA-driven Retainage bills aimed at modifying in our favor how private and public construction projects have historically restrained contractors by needlessly tying up funds) were our focus at the PCA lunch meeting. That gathering – which featured bill-sponsor State Senator Linda Holmes – came "full circle" later, this April, when a PCA delegation at IMSCA's annual Lobby Day further educated state lawmakers on the Retainage bill and other key matters. And last summer the PCA revamped, restarted and re-energized our "Plumbing Hall of Fame" with

tremendous results, fulfilling our aim of bringing together our local industry in a spectacular event.

For the remainder of my term as your PCA President, I will always continue to do my best to listen and lead on your behalf. Our Association is committed to taking action to benefit all who belong, and member involvement in the many facets of our industry is encouraged. My goal from day one for <u>all</u> of us to be "all in" is unchanged. Neither is my belief that *none of us is as strong as all of us*.

# LOCAL 130 SUMMER PERMIT PROGRAM

## **Summer Permit Program Returns for 2023**

Plumbers Local 130 has announced that effective June 1 through September 15, 2023, signatory contractors may employ young men and women (who have completed the 10th grade) in <u>non-jurisdictional</u> work under the following requirements:

- ⇒ An application must be completed at one of the Local 130 offices (Chicago, Joliet, Warrenville & Volo)
- ⇒ Compensation will be no less than the per hour rate of an Mc classification (\$14.75)
- ⇒ Work on any job that requires certified payroll (e.g., Illinois Prevailing Wage or Davis Bacon projects) is not allowed.
- ⇒ Applicants to be hired must possess a valid driver's license or state ID.
- ⇒ Must submit a letter of intent to hire from a Local 130 signatory contractor.

### **IMSCA LOBBY DAY**

### Whatever It Takes: IMSCA Lobby Day 2023 Made an Impact!

The work, mission and impact of IMSCA were fully on display at our 2023 Lobby Day in Springfield on April 26. Not a moment was wasted as virtually every member segment of the Illinois signatory construction industry converged on our State Capitol for a packed day of discussion, information and advocating for legislative goals beneficial to our IMSCA affiliates. Making the event more substantial was that ICIC concurrently met and lobbied (by design, on purpose) on pertinent topics, followed later by our jointly hosted legislative reception.

With an abundant and strategically planned schedule, the business portion of the IMSCA meeting was admittedly (and deliberately) brief and to the point. Executive Director Jessica Newbold Hoselton's thorough explanations of all significant House and Senate Bills provided precisely the proper preparation our "delegations" of IMSCA lobbyists needed and utilized for their visits with the state legislators.



The tone for our tasks at hand was ably set during the luncheon by our guest speaker, Patrick Pfingsten with his aptly titled presentation: "Breaking Through the Noise of Illinois Politics." The founder of *Pf Communications* and publisher of the frank and colorful daily political report known as *Illinoize* provided a wide and interesting array of perspectives and analyses of the comings and goings (and the goings-on) across Illinois and in our large metropolitan areas (mainly Chicago!). Pfingsten fielded audience questions and comments throughout, resulting in a compelling and perceptive exploration of our state's unique blend of politics and people who make it happen.

SB 133 with the goal of modifying Retainage on public construction projects was our focal point. Thanks to materials developed by Jessica, providing an explanation and especially citing the example of IMSCA's success getting the Private Retainage legislation passed a few years back made for solid reasoning why it makes sense and how freeing up funding can facilitate *more* work.

<u>Update</u>: On May 19, 2023, a procurement omnibus bill, HB 2878 Senate Amendment 2, was introduced. Most important to IMSCA is the inclusion of the proposed retainage reduction language that is IMSCA's top legislative priority this session. It provides that retainage may be withheld at a rate of 10% for the first half of a public construction project but reduced to 5% upon 50% completion. This provision will apply to every county, township, municipality, municipal corporation, school district, school board, forest preserve district, park district, fire protection district, sanitary district and all other local governmental units. Passed in both chambers, it is expected to be signed into law soon by Governor Pritzker.

The association delegation that together visited with lawmakers on Lobby Day included PCA officers Kelly Castrogiovanni and Rick Kuhn (with S.J. Peters); SMACNA Executive VP Tony Adolfs; and Dan Allen and Jennifer Rice of CISCO.

In closing, our thanks to everyone who attended and supported IMSCA's 2023 Lobby Day through their participation, generous sponsorships, and willingness to promote our legislative goals with the elected officials and their support staff. Well done! We are looking forward to next year.

## MARCH 8 MEMBERSHIP MEETING

### **PCA March 8 Membership Meeting Recap**

Nearly 60 PCA members, associate members and invited guests enjoyed a productive and enjoyable evening of information, networking, socializing and great food at our March 8 dinner meeting held at Perry's Steak House in Schaumburg, IL. The program content was an explanation led by Pension (management) Co-Chair Michael Kerrigan and PCA-appointed Fund Counsel Wes Covert on the voluntary 401k proposal (effective 1/1/24) for those covered by the Local 130 DC Pension to add their own contribution to further enhance their retirement savings if they choose. The proposal was ratified by our contractor members by a substantial margin through the secret ballot vote.

A summary of the 401k includes the following provisions: as of January 2024, participation will be voluntary for employees (Local 130 members) who will be able to opt-in through a form collected by the Union and provided to the Contractor along with the referral slip. Deductions will be weekly in \$0.50 per hour increments (based on regular pay and OT). Changes to the withholding amounts can be made only once per year by July 1, effective for the payroll period occurring on or after July 1. Employees may terminate their deduction at any time but can only resume them on the next following July 1. 401k deductions will be sent with other contributions and deductions (Pension, Welfare, Union dues, Industry Fund, JAC, etc.). Due dates remain the same as in the current CBA. For example, January contributions are due February 1, with a grace period of no liquidated damages or interest until February 15. The contribution report form will be modified to collect the additional data.

# **Double Time is Required for Official Holidays and Sundays**

This year, Independence Day (the Fourth of July) falls on a weekday. The official observed date of this national holiday in 2023: Tuesday, July 4. Therefore, according to the Plumbers' Local 130 & PCA Collective Bargaining Agreement, Local 130 members if they are scheduled to work on 7/4/2023 (as with all CBA recognized holidays) must be paid at double (2x) the standard hourly rate. Also, please note that the PCA-Local 130 CBA requires double time to be paid only in relation to these following holidays (whether on the actual date or the officially "observed" date): New Year's Day, Memorial Day, Labor Day, Thanksgiving Day and Christmas Day.

You may also submit the information by fax the information to 630-960-5487 or call the PCA office at 312-563-9526. The PCA will promptly and politely notify the "offender" and IDPH officials (and we will not reveal who reported it). Whether it's an oversight, an error or a "handyman" deceptively posing as a legitimate contractor authorized to perform work in our trade, plumbing for paying customers that is performed in the absence of a valid and current license and contractor registration is unlawful and it puts consumers at risk. Help us help you protect public health and prevent unqualified and illicit "posers" from illegally performing plumbing work.

## **UAC COLLECTIVE BARGAINING SEMINARS**

# UAC Collective Bargaining Seminar - 2023 Focus on Preparation for Effective Union Contract Negotiations January 30 seminar took place in Bloomington, IL; "Encore" presented April 5 in Oak Brook, IL

An engaged audience of both seasoned and novice association bargaining team members concentrated on education and preparation for union contract negotiations at the UAC's Constructive Collective Bargaining Seminar in Bloomington, Illinois, on January 30 and again as an "encore" on April 5 in Oak Brook, IL. Planned and presented by the Union Affiliated Contractors (UAC), a PHCC Business Interest Group, the full-day event on both dates drew in more than 50 attendees comprised of signatory PHCC-affiliated contractors and association officials from eight states.

The event was an example of collaboration at its best – with PHCC's UAC, PHCC of Illinois, and the PCA of Greater Chicago (plus generous sponsors Milwaukee Tool, Bradford White and Screen Safe) working together to offer the first UAC in-person meeting in about three years.

#### Better Outcomes for Both Sides

PHCC—National President and UAC Vice Chair Dave Frame (of Bob Frame Plumbing Services - South Bend, IN) set the tone for a day devoted to substantial learning as he welcomed the registrants. "The PHCC aims to help members run better businesses through education, networking, and resources," Frame emphasized. "Signatory contractors, like you and me, occupy a distinct and crucial role in our trade. We set the benchmark for all contractors for the most skilled and capable technicians. PHCC contractors are up to *all* challenges. The fact that we're all here proves that we persevere."

In his opening remarks, UAC Chair Brian Rich (of G. A. Rich & Sons in Deer Creek, IL) cited the value of building and maintaining mutually respectful and productive relationships with our union colleagues. "As contractors, we prefer competent competition to keep up our industry standards. The same is true with us and our union counterparts. When both sides come to bargaining prepared and organized, the process improves. It's one reason that the UAC has made contractor education a cornerstone of what we do for you. Bargaining is one of many topics we plan to cover, yet it may be the most significant. Insights, instruction, best practices, and advice on CBA negotiations will be an ongoing UAC effort."

Building Blocks of Information and Preparation for Bargaining The seminar offered four distinct sessions focused on specific areas of collective bargaining. Appropriately, the first presentation, "Basics of Bargaining", by attorney Richard Samson of Ogletree-Deakins in Chicago served both as a refresher for attendees who had been previously involved in union contract negotiations as well as a primary tutorial for beginners. Included were definitions of terms, overviews of standard practices, and common sequences of events.

The second seminar session – led by attorney John Nesse of Management Guidance LLP in St. Paul, MN – explored how a

chapter's negotiating team can properly lay the groundwork for negotiations. "Doing Your Homework: Planning and Preparation by the Association for Bargaining" explored research techniques covering items such as industry hours, benefit funding levels, results from other trades' settlements, economic information, the political climate, and other relevant data. Pertinent advice on a variety of "do's and don'ts" and general behavior advice throughout negotiations also was offered.

The third session – conducted by attorney Christina Wernick of Laner-Muchin in Chicago – examined bargaining from the labor side's point of view. During "Understanding the Union's Goals and Priorities in Contract Negotiations," attendees gained insights into the priorities that come into play as our counterparts

seek a satisfactory settlement, and the tactics and resources unions apply toward that aim. Since Wernick spent a number of years as legal counsel to a large construction union and its benefit funds prior to joining this management-focused firm, she was able to offer unique and practical perspectives from both sides of the bargaining table.

Samson returned to present the next session, which provided a more advanced look at union contract negotiations. As the name suggests, "Beyond Bargaining: A 'Nuts & Bolts' Overview of Negotiations in a Multi-Employer Setting" covered a range of more complex areas of contract talks. Among the topics covered in depth were contract types; bargaining rights delegations; deadlocks, strikes and lockouts; minute taking; bargaining team formation and spokesperson selection; interim agreements; tentative agreements on specific proposals; ratification procedures; and other higher-level considerations.

### **Rounding Out an Information-Packed Day**

To close the seminar, S.J Peters (PCA Executive Director and UAC Advisory Board member) moderated a panel discussion and Q&A forum featuring all three of the day's presenters: Nesse, Samson, and Wernick. Audience questions were addressed "live" and via index cards for anonymity. In addition, the presenters furnished in advance a comprehensive list of questions "we wish contractors would ask but rarely do." The nearly 90-minute discussion covered a mix of pertinent subjects from bargaining, to trust funds, to grievances, to jurisdictional issues, to reciprocity when working outside of the union's territory, to CBA duration considerations, and more.

The UAC and PHCC thank and acknowledge the sponsors: Milwaukee Tool, Bradford White and Screen Safe for their generous and consistent support. Also deserving of recognition is the PHCC—National staff, particularly Senior Director of Member Services and Customer Care Kim Dresser. The planning committee also relied on and appreciated the leadership and direction from PHCC—National President Dave Frame; UAC Chair Brian Rich; and the "trifecta" of Illinois PHCC State Chapter Executive Director Bev Potts and the Bloomington/Normal Chapter for arranging and overseeing the meeting site; Illinois State Chapter Associate Director Shelly Lott for coordinating all the graphic design for print and electronic communication; and S.J. Peters of the PCA of Greater Chicago for taking charge of program content and serving both as the day's emcee and photographer. The UAC also recognizes SMACNA Greater Chicago for arranging the event/class space for the April encore. Finally, our gratitude to the seminar speakers for their relevant and outstanding presentations: attorneys John Nesse, Richard Samson, and Christina Wernick. # DRUG FREE ALLIANCE

### PCA & Local 130 Drug Free Alliance Information

The PCA/Local 130 CBA requires random/mandatory drug testing for all rank & file UA members and the nonbargained staff of PCA signatory employers who elected to "opt-in" to the program. Contractors who have not "opted-in" are not required to include their "non-bargained" employees (contractors, managers, administrative & sales staff, etc.) in the Drug Testing Participant Pool. All rank & file UA Local 130 members continue to test.

Please note: When eligible employees are notified to take the drug test, most locations now require a barcode. Employees can contact ScreenSafe to set one up or using their email address; employees may now register online to save time. Once registered, they will receive a "bar code through email or text that they will show at the collection site to minimize paperwork and speed up the process. (Also: all Union Wellness Centers are test collection sites for Local 130 members – see back cover.)
